Matt Bond is a long time member of VJJA's Capital District Chapter and is seeking election as a District Chair. Currently, Matt serves as Vice Chair. Matt was first employed by the Department of Juvenile Justice (DJJ) in 2000 as a wage Probation Officer. In 2002, he obtained fulltime employment as a Probation Officer with the 14th District Court Service Unit - Henrico, and continued in that role until 2011 when he was promoted to Senior Probation Officer. Matt has also served in the role of Courtroom Expeditor. In 2012, Matt was promoted to his current role of Probation Supervisor. In that role, he supervises the Courtroom Expeditor Unit. Matt is a certified instructor for the Effective Practices in Community Supervision (EPICS) curricula. Matt was the 2020 recipient of VJJA's Meritorious Award in the Area of Court Services. He obtained a Bachelor of Science degree in Criminal Justice from Virginia Commonwealth University. He is also a graduate of the Department of Juvenile Justice's inaugural Justice Transformation Institute (JTI) -Cohort I. Pre-pandemic, Matt was a frequent traveler and "island hopper". Originally from Northern Virginia, when not traveling, Matt makes his home in Richmond. If elected VJJA Capital District Chair, Matt is looking forward to establishing an active VJJA Local Advisory Board (LAB) representing the diversity of workplaces in the Capital District. LeKeisha began her career with Department of Juvenile Justice (DJJ) in 2005 as a Rehabilitation Counselor at Beaumont JCC. From 2007 until 2012, she worked in supervisory roles within the community mental health field in the areas of therapeutic day treatment and intensive in-home services. LeKeisha returned to DJJ in 2012 as a Counselor Supervisor at Beaumont JCC, a position she held until 2015 when she was promoted to Community Coordinator. During her tenure with DJJ, LeKeisha has supervised the Sex Offender and Aggression Management & Substance Abuse (AMSA) treatment units, as well as the Intensive Redirection Behavior Unit (IBRU) and the Work/Education Release Program (WERP). In 2016, LeKeisha was named Acting Community Manager at Beaumont JCC and later promoted to Community Manager at Bon Air JCC, where she was responsible for the Community Treatment Model units, to include the Sex Offender treatment units, Vulnerable Populations Unit, as well as the resident work and apprenticeship programs.
