

## W. Stephen Pullen Youth Scholarship Application

VJJA Members are eligible to nominate a youth who, through their involvement in the juvenile justice or human services system, had overcome personal obstacles to transform themselves into an individual demonstrating personal accomplishment.

The President's Child Advocacy Fund, named in memory of long time child advocate Steve Pullen, provides the award winner(s) a scholarship to be used towards higher education with current attendance or plans to attend a four (4) or (2) year institute of higher learning, including trade or vocational programs, and must demonstrate a need financially.

## **Eligibility Criteria**

- 1. Person's nominating must be a current member of the Virginia Juvenile Justice Association, in good standing.
- 2. Nominee must be a resident of the Commonwealth of Virginia.
- 3. Nominee must be between the ages of 17 and 21 years.
- 4. Nominee must have current or past involvement in the juvenile justice or a human services system.
- 5. Nominee is attending or planning to attend a four (4) or two (2) year institute of higher learning, including trade or vocational programs, and must show a need financially.
- 6. Nominee has have demonstrated overcoming personal obstacles to achieve significant accomplishments.

## **Nominations**

The Selection Committee will review and discuss all nominations and select the award recipient. VJJA will recognize appropriate boundaries of confidentiality when handling application forms including personal or sensitive information about nominees.
